RFQ OVERVIEW

1. Introduction

1.1 Background

The key outcome of this RFQ is to establish a competitive pricing framework through bulk discounting for the identified Goods and Services (already covered in Agreement No: **999 ICT End User Devices and Services for NSW Government** which will deliver improved value to Customers based on estimated volumes

This RFQ invites selected Contractors appointed under Agreement no: **999 ICT End User Devices** and **Services for NSW Government** to supply the listed items. It is the intention where possible, to appoint one contractor as the preferred supplier for the Goods/Services listed in Statement of Requirements of this RFQ.

This Request for Quotation ("RFQ") is issued by the Principal under clause 2.15 (a) Negotiation for increased Bulk Purchase Discounts in Agreement No: 999 ICT End User Devices and Services for NSW Government for the supply of ICT End User Devices and Services for NSW Government to Customers.

The Principal wishes to achieve greater value from its panel arrangement under Agreement no: **999 ICT End User Devices and Services for NSW Government** within the term of that Agreement, and has analysed and developed opportunities to achieve this.

CONDITIONS OF QUOTATION

2. RFQ Preparation

2.1 Respondent to inform itself

Before submitting its quotation, a respondent must:

Examine all information relevant to the risks and contingencies and other circumstances having an effect on its Quotation; and

Satisfy itself:

that the price is correct; and

(a) that it is financially and practically viable for it to enter into and perform the Customer Contract to be established under Agreement No: 999 ICT End User Devices and Services for NSW Government

3. RFQ Process

3.1 Quotation Lodgement

Quotations (including all supporting information, if any) must be submitted electronically in accordance with this RFQ and fully received by the Closing Date and Closing Time. Respondents must complete all of the Response document and must not amend any of the questions provided. Prices, responses and other information provided in the quotation must be in writing and in English. The quoted price must be in Australian dollars.

The quotation must be submitted electronically to the electronic tender box for this RFT via the NSW Department of Finance, Services and Innovation's tenders website at: https://tenders.nsw.gov.au/commerce (Login in as a system user, locate the web page for this RFQ, and follow the on screen instructions to lodge the quotation. The lodgement can only be made by a registered system user of the NSW Government eTendering system.

Respondents should notify the Contact Officer in writing on or before the Closing Date and Time if they find any discrepancy, error or omission in this RFQ.

A respondent, by lodging a quotation (electronically or otherwise), is taken to have accepted conditions shown in the Conditions and rules on the NSW Department of Finance, Services and Innovation's tenders website at https://tenders.nsw.gov.au/commerce.

3.2 Quotation Validity Period

The quotation will remain open for acceptance by the Principal for a period of 6 months from the Closing Date and Time for quotations.

3.3 Corruption or Unethical Conduct

Respondents must comply with the requirements of the NSW Department of Finance, Services and Innovation's Business Ethics Statement, which is available at the link below and must disclose any conflicts of interests in Response.

If a respondent, or any of its officers, employees, agents or sub-contractors is found to have:

- offered any inducement or reward to any public servant or employee, agent or subcontractor of the Principal, Customer or the NSW Government in connection with this RFQ or the submitted Quotation;
- committed corrupt conduct in the meaning of the Independent Commission Against Corruption Act 1988;
- a record or alleged record of unethical behaviour; or not complied with the requirements of NSW Department of Finance, Services and Innovation's Business Ethics Statement available at: https://www.finance.nsw.gov.au/about-us/business-ethics

this may result in the quotation not receiving further consideration.

The Principal may, in its discretion, invite a relevant respondent to provide written comments within a specified time before the Principal excludes the respondent on this basis.

If the Principal becomes aware of improper conflict of interests by a successful respondent after an Agreement has been executed, then the Principal reserves the right to terminate the General Conditions of Contract that has been made under it.

Respondents must comply with the requirements of the **NSW State Emergency Service Code of Conduct Statement**, which is attached.

3.4 Goods and Services Procurement Policy Framework

In submitting its quotation, the respondent signifies agreement to comply with the Framework.

Failure to comply with the Framework may be taken into account by the Principal when considering the respondent's quotation or any subsequent quotation, and may result in the quotation being passed over.

3.5 Cost of Respondent's Participation in the RFQ

The respondent acknowledges that the Principal will not be liable to it for any expenses or costs incurred by it as a result of its participation in this RFQ, including where the RFQ has been discontinued.

3.6 Evaluation Process

Respondent will be assessed against the evaluation criteria listed below which are not indicated in order of significance or equal weight. The evaluation criteria for this RFQ that do not relate to price will account for 40% of the total evaluation score. The evaluation criteria for this RFQ that relate to price will account for 60% of the total evaluation score. Information supplied by the respondent in Response will contribute to the assessment against each criterion.

Respondents are advised to respond clearly to all the evaluation criteria listed in this RFQ. Quotations that do not include a fully completed Response, in particular those quotations which do not contain sufficient information to permit a proper evaluation to be conducted, or electronic quotations that cannot be effectively evaluated because the file has become corrupt, may be excluded from the quotation process without further consideration at the Principal's discretion.

3.7 Evaluation Criteria

The evaluation criteria for this RFQ (which include but are not limited to) are:

Review of Responses

Respondents are advised to respond clearly too all the NSW SES requirements within their response. These responses will be reviewed by an Evaluation Panel through a comparative assessment against the following criteria. The proposal must stand on its own merits and demonstrate compliance to NSW SES requirements.

Schedule 1 – Equipment Supply

Responses for each resolution option will be evaluated based on value for money pricing and satisfaction of quantity, functional and technical requirements described previously. Loan reference devices may be requested to evaluate fitness for purpose.

Schedule 2 - Delivery Method

Responses for each method option will be evaluated based on value for money pricing and risk control measures proposed for on-time delivery assurance.

Schedule 3 – Installation and Disposal (Value-Add Option)

Responses for this schedule will be evaluated based on:

- · Value for money pricing
- Confidence in capacity to deliver with demonstration of relevant experience (requirement to supply customer contact details as a minimum of three (3) referee checks).
- Project management, quality and risk control measures which instils customer confidence that on-time and on-specification delivery, installation and commissioning can be achieved.

Product Showcase and Practical Evaluation

NSW SES shall summon shortlisted vendors to showcase selected products and provide two (2) units on loan for a two (2) week practical evaluation so that the product can be tested in a controlled user environment. The showcase and products presented for practical evaluation will not be at cost to the NSW State Emergency Service.

4. Acceptance or Rejection of Quotations

The Principal is not bound to accept the lowest or any quotation.

5. Exchange of Information between Government Agencies

- 5.1 By lodging a quotation the respondent will authorise the Principal to make information available, on request, to any NSW government agency. This includes information dealing with the respondent's performance on any prior contract that has been awarded. Such information may be used by the recipient NSW Government agency for assessment of the suitability for pre-qualification, selective tender lists, expressions of interest or the award of a contract.
- 5.2 The provision of the information by the Principal to any other NSW Government agency is agreed by the respondent to be a communication falling within section 30 of the Defamation Act 2005 (NSW), and the respondent shall have no claim against the Principal and the State of New South Wales in respect of any matter arising out of the provision or receipt of such information, including any claim for loss to the respondent arising out of the communication.

6. Disclosure Information

- **6.1** Following the Principal's decision, all respondents will be notified in writing of the outcome of their quotations.
- Details of this quotation and the outcome of the quotation process will be disclosed in accordance with the Government Information (Public Access) Act (NSW) and the Premier's Memorandum 2007-01.

STATEMENT OF REQUIREMENTS

1. Introduction

As the legislated combat agency, the NSW State Emergency Service (NSW SES) is responsible for planning and conducting the emergency response for Flood (including Flood Rescue), Storm and Tsunami within NSW. In addition to our legislated responsibilities, the NSW SES has a dedicated and committed volunteer workforce skilled in a range of operational capabilities which complement and support other full time and volunteer emergency services including a range of accredited rescue activities. The NSW SES operates seamlessly and cooperatively with the other emergency services and has a world class disaster response capability that is often deployed interstate and overseas.

The NSW SES employs more than 270 staff strategically located across NSW with the State Headquarters in Wollongong. The organisation has a membership of approximately 8,500 volunteers, situated at 228 locations (units) across NSW.

In the current paradigm of emergency response to the Services combat roles of Flood, Storm and Tsunami, the NSW SES utilises operational management systems and tools for capturing requests for emergency assistance from members of the public, dispatching resources and in combination with numerous other disparate information systems and manual practices, ensures an operational response of volunteers.

2. Scope

This Request for Tender (RFT) is for the supply and delivery of computer monitors (visual displays) for the members of the NSW SES. NSW SES requirements are

2.1 Timeframes

It is a requirement that all goods are supplied by the 8th June 2019 for goods receipting.

2.2 Schedule 1 - Equipment Supply and Pricing

Quantities and Pricing

The quantities of equipment are as follows:

- a) Supply and pricing of computer monitors amounting to a quantity of **850** units.
 - It is assumed that these monitors will be supplied, by default, with a display input cable. Please provide confirmation that this is the case and what cable variant is supplied (HDMI and DisplayPort are preferred).
- b) If a display input cable is not supplied by default, supply and pricing for both 1.5m HDMI and DisplayPort cables amounting to a quantity of **850** units.
- c) Opportunity for further supply of monitors beyond initial quantity. The proposal should include quantity break pricing for bulk purchasing.

Resolution Options

The NSW SES is seeking quotes for two monitor resolution options:

- Monitor Option 1: 2K resolution (preferred)
- Monitor Option 2: 1080p resolution

Functional and Technical Requirements

Each option also should satisfy the following requirements (in below table) which have been prioritised based on the NSW SES's needs. Requirements are prioritised as follows:

Mandatory [M] – a <u>must-have</u> requirement; all mandatory requirements need be satisfied in order for NSW SES to consider proposal.

Highly Desirable [HD] – a <u>should-have</u> requirement; a high priority item which will add value to the respondent's proposal if satisfied. A significant influence, but not vital.

Desirable [D] – a <u>could-have</u> requirement; a moderate priority item. A small value-add influence.

2.3 Schedule 2 - Delivery Method

Direct delivery of monitors to NSW SES Facilities is a desirable requirement within this Tender. There are approximately two-hundred and fifty (250) NSW SES facilities across NSW. These facilities are typically unattended and require advanced notice to provision access or an agent (typically an unpaid volunteer) to receipt delivery of goods.

Respondents shall provide a proposal which outlines the three delivery options below and describe how implementation, controls, risk and quality will be managed with due consideration of access challenges described above.

2.4 Delivery Option 1 (Preferred) – Managed Delivery

That specified quantities of goods be supplied and delivered to each NSW State Emergency Service facility across NSW directly. See **Attachment A** for the list of facility locations.

2.5 Delivery Option 2 – External Warehousing and Staging

Where the supplier can provide suitable storage of these goods for a period of up to 3 months, following date of purchase until such time comes that these are required for installation at various locations across the state.

2.6 Delivery Option 3 – Centralised Delivery

All goods be supplied and delivered to the NSW State Emergency Service, State Warehouse in Coniston NSW.

2.7 Schedule 3 – Installation and Disposal (Value-Add Option)

The NSW SES will consider, if provided, proposals which include the installation of supplied monitors, disposal of refuse, and decommissioning of displaced old monitors. The NSW SES requires the recording of information and supply of documentation of site-by-site inventory of installed and disposed equipment (monitors), including serial numbers.

3. Tender Administrative Details

3.1 Response Format and General Requirements

Respondents are invited to submit a quote and proposal to this request in writing by the closing date.

4. Tender Closing Date

Tender for the above hardware closes: **Friday 10th May 2019 at 10:00am**. Late submissions will not be considered as time is of the essence in this process.
