Overview

Suppliers

Due to the recent bushfires, the NSW Government would like to hear from anyone that may have capability and capacity to provide goods and/or services in affected regions. This portal will cover any goods or services; including those not available on our whole of government arrangements. It is an easy registration process containing some simple questions.

Buyers

If you are NSW Government buyer (including private hospitals, local councils, non-profit organisations, educational institutes and public authorities) or a private buyer you can use this portal to enter information about your programs of bushfire recovery work.

Purpose

The purpose of this portal is to connect government buyers with regional suppliers and vice versa. It assists buyers to give first preference to appropriate local suppliers based in affected regions. Any information gathered through this portal that is not commercial-in-confidence will be publicly available on the Procurepoint website so that everyone can access it.

Sourcing

This is a list of registered suppliers that have indicated capacity and capability to do works in bushfire affected regions. IT IS NOT A PREQUALIFICATION SCHEME. The suppliers are not assessed for capability at time of application.

You can use this portal to find information and contact details of suppliers in the region in which you wish to source; then refer to your agency's procurement guidelines for advice on how to engage. It is your responsibility to choose a relevant procurement and engagement method; e.g. purchase orders or p-cards where appropriate.

For ease of use; particularly for low value / low risk engagements you can raise an RFx through eQuote.

The information contained in the portal is correct at time of publication. The NSW Government does not guarantee the suitability of a supplier for the particular work required. It is up to the buyer to perform the necessary due diligence based on the risk at time of engagement.
