**What is the purpose of the scheme?**

The Government Architect NSW's (GANSW) objective is to ensure the Government has the ability to make informed design decisions, through early engagement on projects, better project definition, scoping and procurement.

Assisting Government to deliver quality outcomes in the built environment – the Government Architect's Strategy & Design Prequalification Scheme (the scheme) is focused on the delivery of strategic planning advice, design quality and innovation in the built environment.

The scheme will offer a streamlined approach for both service providers and Government that relates to the NSW Treasury Gateway Review process. The consultancy categories are structured to coincide with the requirements of the NSW Government procurement framework.

In addition to the usual scheme probity standards, agencies will benefit from the expert assessment and evaluation of service providers that the scheme delivers.

As a benefit of the scheme agencies will have ongoing access to advice and design expertise from GANSW throughout each engagement. This expertise will streamline and de-risk the engagement process and support agencies in delivering better built outcomes.

The scheme also aims to develop and broaden industry capability through nurturing and supporting Small and Medium Enterprises (SME) or emerging businesses.

**What are the scheme categories?**

The scheme aims to provide agencies with access to skilled and experienced firms and emerging businesses which supply Strategy and Design services.

A specific category has also been developed to encourage Emerging Design Practices to seek prequalification.

The scheme work categories include:

**1. Strategy**

- (a) Project Initiation, Definition, Justification and Risk Assessment
- (b) Project Governance and Management
- (c) Business Case Development
- (d) Financial and Economic Analysis
- (e) Stakeholder Engagement and Management
- (f) Strategic Planning
- (g) Aboriginal Cultural and Spatial Intelligence

**2. Design**

- (a) Architecture
- (b) Urban Design
- (c) Landscape Architecture
- (d) Emerging Practices

**What are the benefits of the scheme?**

The scheme aims to reduce red tape and the cost associated in doing business with government.

The scheme has simple standard contracts (for both strategic and construction related services) and allows single invited tenders for engagements up to \$250,000 (incl GST). Scheme conditions align with the Security of Payments Act.

The Scheme supports the delivery of 'good design' as defined in the Environmental Planning and Assessment Act and Better Place Policy.

**How does my business obtain Prequalification?**

Applications will be assessed and evaluated via an Assessment Panel chaired by the Government Architect to determine eligibility for participation in the scheme.

Applicants are required to apply online through NSW eTendering: [www.tenders.nsw.gov.au](http://www.tenders.nsw.gov.au).

Only applications which fully satisfy all requirements set out in the scheme conditions and the online service provider application will be considered by the Assessment Panel.

**Timing of the scheme**

The scheme was established in 2014. Applications can be made anytime with assessments taking place quarterly.
